

**PANDEMIC – HIGH RISK**  
INT’L, U.S., and LOCAL MISSIONS – VULNERABLE ADULT AND MINOR  
LEGAL RELEASE, PERMISSION AND INDEMNIFICATION AGREEMENT

I hereby give permission for my dependent adult or child (“my dependent”), named below, to participate in one or more mission trips and community service activities and possibly including transportation by aircraft, bus, van, car or other form of transportation (collectively, the “Activity”).

In consideration of the acceptance of my dependent’s participation in the Activity sponsored by Southeast Christian Church of Jefferson County, Kentucky, Inc. (the "Church") and as an inducement to planning the Activity and permitting my dependent to participate, the undersigned (hereinafter, “I”) agrees as follows:

**Participation in the Activity includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Releasees (defined below), or others, and assume full responsibility for my participation; and, I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases.**

I give my permission to the Church or its designees to secure medical treatment for my dependent. I also give my permission to the medical personnel selected by the Church or its designees to secure treatment and provide for the complete medical care of my dependent.

I, on my behalf and on behalf of my dependent, hereby fully and forever release and waive and agree not to bring or cause to be brought any and all claims, demands, actions, or causes of action of every possible kind and nature whatsoever I or my dependent might assert, including, without limitation, claims for personal injury, wrongful death, or property damage, whether or not absolute, known or unknown, or otherwise against the Church or any of its elders, officers, employees, representatives, agents and volunteers (collectively referred to herein as the "Releasees") by reason of, arising out of or relating to my dependent’s participation in the Activity. I, on my behalf and on behalf of my dependent, release the Releasees and waive all such claims against the Releasees for any injuries or damages caused in any manner whatsoever whether or not any such liability is attributable to the absence of ordinary or even slight care by the Releasees arising out of the Activity.

I, on my behalf and on behalf of my dependent, further agree to indemnify, defend and hold the Releasees harmless from any kind of compensatory or punitive damages sought to be recovered from the Releasees and all losses sustained by the Releasees independent of claims asserted by others, including, without limitation, general damages, property damage, special, incidental and consequential damages, losses or expenses suffered or paid, directly or indirectly, as a result of any and all claims, causes of action, suits, proceedings, demands, judgments, assessments, and liabilities, including reasonable attorneys' fees incurred in litigation or otherwise, assessed, incurred or sustained by or against the Releasees by reason of, arising out of or relating to my dependent’s participation in the Activity.

I give the Church, and any person acting under its authority permission to publish, distribute, broadcast, televise, promote, license, sell and copyright for all purposes, any photograph, videotape, motion picture or sound recording produced directly by the Church or under its sponsorship, which may include the image or likeness of my dependent and/or the voice of my dependent. I also authorize the Church to reproduce, amplify, simulate, filter or otherwise distort the voice of my dependent and all instrumental musical and other sound effects produced by my dependent. In addition, I authorize the use of any printed material in connection therewith. I release, on my behalf and on behalf of my dependent, all claims against the Church with respect to copyright ownership, publication and right to privacy. I agree that neither I nor my dependent shall receive any fee and that all rights, title, and interest to the above materials and use of them belong to the Church. I understand and agree that these materials may be duplicated or distributed with or without charge, and/or altered in any form or manner without future/further compensation or liability, in perpetuity.

I further agree that I have read and understand this Agreement; my dependent will not drive any type of motor vehicle while participating in the Activity; my dependent will not use construction or landscaping tools or equipment; the execution of this Agreement is continuing in nature; it is my knowing and voluntary act on my behalf and on behalf of my dependent; this Agreement is binding upon me and my dependent’s heirs, executors, administrators and legal representatives; I am under no duress or undue influence to execute this Agreement; I represent that the information provided in my dependent’s application to participate in the Activity is true, complete and correct in all respects; it is my intention with this Agreement, on my behalf and on behalf of my dependent, to make a complete, general, and unconditional release of any and all claims whatsoever against the Releasees, as set forth above.

This Agreement shall be effective from the date signed below until the date of the receipt of a written declaration signed by the parent or legal guardian, that this Agreement shall no longer be effective with regard to any act or event from and after the date of the receipt via U.S. Mail of the written declaration addressed to Southeast Christian Church of Jefferson County, Kentucky, Inc., 920 Blankenbaker Parkway, Louisville, KY 40243-1845, attention: General Counsel.
