

HIGH RISK - ADULT RELEASE AND INDEMNIFICATION AGREEMENT

DISASTER RESPONSE

In consideration of the acceptance of the undersigned's application for participation in various serving projects with a ministry of Southeast Christian Church of Jefferson County, Kentucky, Inc. (the "Church"), including, but not limited to, storm disaster response, demolition, hazardous and contaminated debris removal, heavy equipment operation (if certified), assistance in human and animal rescues by boat, by entry into damaged and unstable buildings, and other means; construction, renovation, home improvements, gutter and roof repairs, tree removal, use of dangerous equipment such as chain saws, climbing ladders, climbing trees, preparing and distributing food and hygiene items, heavy duty cleaning, heavy lifting, outdoor clean up, and transportation by bus, van, car or other form of transportation (each referred to herein as the ("Activity")) and as an inducement to organizing the program and permitting the undersigned's participation therein, the undersigned agrees as follows:

I understand that the Activity is highly dangerous. I acknowledge that participating in the Activity entails risks that could result in physical or emotional injury, paralysis, death, or injury or damage to me, to property, or to third parties. I understand that the disaster relief sites in which I will be volunteering are dangerous and unstable by nature, including risks such as adverse weather, downed electrical lines, collapsing structures, flooding, broken glass and debris, contaminated and infectious substances, and volunteers handling tools and equipment in close proximity. While particular rules and personal discipline may reduce this risk, the risk of serious injury, illness and death does exist; and I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Releasees (defined below), or others, and assume full responsibility for my participation; and, I willingly agree to comply with the stated and customary terms and conditions for participation.

Participation in the Activity includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Releasees (defined below), or others, and assume full responsibility for my participation; and, I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases.

The undersigned hereby fully and forever releases and waives and agrees not to bring or cause to be brought any and all claims, demands, actions, or causes of action of every possible kind and nature whatsoever the undersigned might assert, including, without limitation, claims for personal injury, wrongful death, or property damage, whether or not absolute, known or unknown, or otherwise against the Church or any of its elders, officers, subsidiaries, employees, representatives, agents and volunteers (collectively referred to herein as the "Releasees") by reason of, arising out of or relating to the undersigned's participation in the program. The undersigned releases the Releasees and waives all such claims against the Releasees for any injuries or damages caused in any manner whatsoever whether or not any such liability is attributable to the absence of ordinary or even slight care by the Releasees arising out of the program.

The undersigned further agrees to indemnify, defend and hold the Releasees harmless from any kind of compensatory or punitive damages sought to be recovered from the Releasees and all losses sustained by the Releasees independent of claims asserted by others, including, without limitation, general damages, property damage, special, incidental and consequential damages, losses or expenses suffered or paid, directly or indirectly, as a result of any and all claims, causes of action, suits, proceedings, demands, judgments, assessments, and liabilities, including reasonable attorneys' fees incurred in litigation or otherwise, assessed, incurred or sustained by or against the Releasees by reason of, arising out of or relating to the undersigned's participation in the program.

I further agree that I have read and understand this Agreement; the execution of this Agreement is continuing in nature; it is my knowing and voluntary act and I am under no duress or undue influence to execute this Agreement.

I give Southeast Christian Church, and any person acting under its authority permission to publish, distribute, broadcast, televise, promote, license, sell and copyright for all purposes, any photograph, videotape, motion picture or sound recording produced directly by Southeast or under its sponsorship, which may include the image or likeness of me. I also authorize the Church to reproduce, amplify, simulate, filter or otherwise distort my voice and all instrumental musical and other sound effects produced by me. In addition, I authorize the use of any printed material in connection therewith. I release all claims against the Church with respect to copyright ownership and publication. I agree that I shall not receive any fee and that all rights, title, and interest to the above materials and use of them belong to the Church. I understand and agree that these materials may be duplicated or distributed with or without charge, and/or altered in any form or manner without future/further compensation or liability, in perpetuity. I understand that the Church is obtaining this release and assignment of copyright in order to conform to U.S. copyright laws and international copyright treaties and conventions.

This Agreement shall be effective from the date signed below until the date of the receipt of a written declaration signed by the undersigned, that this Agreement shall no longer be effective with regard to any act or event from and after the date of the receipt via U.S. Mail of the written declaration addressed to Southeast Christian Church of Jefferson County, Kentucky, Inc., 920 Blankenbaker Parkway, Louisville, KY 40243-1845, attention: General Counsel.

I am at least eighteen (18) years of age.
